By signing below, I understand I am certifying:

1. I am a resident of Honesdale living east of Church Street and west of the Lackawaxen River or I am a resident of Honesdale living on West Street.
2. I will not use this permit for any vehicle other than the vehicle on this original application.
3. If I dispose of a vehicle and replace it with another, it is my responsibility to notify Honesdale Borough parking enforcement of all new vehicle information tied to my permit.
4. All landlord rental registrations, inspections, licenses, and fees are current. The responsibility is on me to verify compliance with the landlord. Landlords should verify compliance with the borough Zoning Office. Be sure to have your landlord fill out the property owner section.
5. I understand there is no guarantee I will find a parking place in close proximity to my residence. There are no designated parking spaces/meters for anyone.

2. Please have the following items ready to show as proof of residence and ownership:
 - a. Valid Driver's License showing current address (this is the only form of ID acceptable)
 - b. Vehicle Registration in your name showing current address (should match license).
3. Give this to your landlord and he/she (or agent) will obtain permit tags.
